## 4. <u>2021 - 2025 Draft Financial Plan</u>

Corporate report dated January 25, 2021 from the Director of Financial Services titled "2021-2025 Draft Financial Plan".

The Director of Financial Services provided and an overview of the proposed 2021 - 2025 Financial Plan.

Councillor Kristjanson arrived at the meeting at 5:06 p.m.

The following discussion points were noted:

General Fund Operations:

- Loss due to COVID (Decreased Revenues/Decreased Expenses/Increased Expenses and Recoveries - Provincial Government)
- Largest revenue impacts parking / recreation
- Concern was noted with possible deficit for 2021
- It was inquired as to what happens with unspent portion(s) of the grant received by the province. Staff noted that there are a number of items the funds can be utilized for and there is not a time limit to spend the funds
- It is important that the City "tighten its belt", discretionary spending needs to be less
- It was clarified that salary and benefits at \$494,900 include union collective agreement and cost of living
- Pop Up Gallery Lease \$39,400, original lease expires January 31, 2021, will be running month to month following that. It was noted that there are no City locations that can accommodate this use at this time
- Transfer to Reserves, can this be held back for one (1) year? Staff noted it can be a consideration, need to be aware the City should be putting in enough to replace all infrastructure
- HR Advisor, is this necessary has the City explored WorkSafe BC Core Program. Staff noted they have but there is much to do before this is achievable, but remain committed to the City working towards it.
   Staff clarified that this item is to support the employee group including the safety of employees

- We need move forward with the budget, at least must align to continue to do the things we have been doing
- A number of projects in the general fund asset improvement (page 32 of the agenda), are there any that can be deferred or cancelled? Staff noted these items are not a direct link in regard to a tax increase

Staff were asked to schedule a further meeting, as soon as possible, in order to complete consideration of the Finance and Audit Committee meeting of January 25, 2021. It was noted that all remaining Items 4 - 6 will be placed again on the next agenda to be completed at the next meeting.
