**4. REDEVELOPMENT OPTIONS - DISCUSSION WITH URBAN SYSTEMS TEAM**

J.P. Raulot-Lapointe, Urban Systems, attended to further discuss potential Community Hub redevelopment options with the Committee. He presented an updated work plan proposal, engaging in roundtable discussion with members as he reviewed each section of the document.

The following discussion points were noted:

- Three (3) scenarios were presented for potential redevelopment options at the current City Hall site. It was noted that Urban Systems can also incorporate a fourth scenario, which would analyze an approach in which the current RCMP building, along with the Annex, City Hall, Library and Evergreen Daycare site, would all be sold, and where the Community Hub would be built at the Johnston Road site, with a new RCMP location to also be determined (either within the new Community Hub site or in a separate location).
- Financial analyses will be conducted for two (2) potential development options for a new Community Hub at the Johnston Road site (corner of Johnston Road and Russell Avenue): one (1) zoned for a maximum of twelve (12) storeys, and one (1) zoned for a maximum of twenty-five (25) storeys.
- As this process moves forward, the intent will be to seek community feedback regarding what types of services/facilities residents would like to see included within the Community Hub.
