#### **EXECUTIVE SUMMARY**

On June 27, 2024, Council adopted new Zoning Bylaw No. 2506 to incorporate Small Scale Multi Unit Housing regulations for the City of White Rock, as required by Provincial Legislation. Accordingly, an update to the City's Ticketing for Bylaw Offences Bylaw is necessary, for bylaw enforcement purposes.

#### INTRODUCTION/BACKGROUND

On June 27, 2024, Council adopted new Zoning Bylaw No. 2506 to incorporate Small Scale Multi Unit Housing regulations for the City of White Rock, as required by Provincial Legislation. Accordingly, an update to the City's Ticketing for Bylaw Offences Bylaw is necessary, for bylaw enforcement purposes.

The attached draft bylaw No. 2510, found in Appendix A, is a housekeeping amendment to the Ticketing for Bylaw Offences Bylaw. Changes include referencing the new Zoning Bylaw 2506 and updates to the section numbers and their descriptions where required.

There are no changes to the penalties applied for the designated offences.

#### FINANCIAL IMPLICATIONS

Updating the Ticketing for Bylaw Offences Bylaw to reflect the new Zoning Bylaw No. 2506 ensures that the City will be able to ticket for bylaw violations. Tickets are a source of revenue for the City, which helps recoup the costs of enforcement.

# **LEGAL IMPLICATIONS**

By updating the Ticketing for Bylaw Offences Bylaw to reflect the new Zoning Bylaw No. 2506 the City will be able to apply penalties for violations of the City's zoning regulations.

# COMMUNICATION AND COMMUNITY ENGAGEMENT IMPLICATIONS

Ensuring that the City can effectively enforce its regulations helps maintain good relations with the community and responds to community expectations.

# **ALIGNMENT WITH STRATEGIC PRIORITIES**


