- L. Tien, Executive Director, Semiahmoo Arts Society, noted their support for the City's proposed Community Hub and the potential of additional arts and cultural space it will offer.
- A. Anderson, White Rock, concerned with e-bikes on City sidewalks, asked that the bylaws be reviewed and e-bikes be noted as not permitted on City sidewalks (fines & signage should be implemented to clarify this).

It was noted that staff will review this.

 G. Gumley, White Rock, stated concern with the City's lack of clarity around the deadline for accepting submissions in regard to the Financial Plan survey and the fact his submission was not accepted. It was noted that the Mayor and Council had received the email / submission and the Mayor was given a hard copy by Mr. Gumley at this time.

Staff were asked to ensure the deadline for surveys / receipt of submissions be made clear within future communications.

J. Singh Gill, White Rock, noted concern with the impact of Bill 44
legislation and the recent City Zoning Bylaw amendments made to
accommodate it (RS-1 and RS-2). The floor area calculation
definition has been amended to include open areas (including stairs
and deck space) within the required calculations. Previously they
there not and asked if this can be reviewed.

Staff noted they are reviewing the Bylaw at this time.

- D. Moffy, White Rock, noted the same concerns as Mr. Gill in terms
 of the new Zoning Bylaw in regard to the calculation of floor area
 and asked that Council consider the new bylaws and their potential
 impacts.
