EXECUTIVE SUMMARY

The 2024 Annual Report includes statistical information, departmental overviews, information on civic grants-in-aid, permissive tax exemptions, and capital projects. The last portion of the report contains detailed financial statements for the city, year ended December 31, 2024.

The document also includes a summary of 2024, the progress status on Council's Strategic Priorities, and statements from the Mayor and Chief Administrative Officer.

Once completed, the annual report must be available for public inspection 14 days prior to being presented to Council to receive public submissions and questions. The City's Annual report was available on Monday, June 9, 2025.

In accordance with the *Community Charter*, the municipality is to have the Annual Report completed by June 30.

INTRODUCTION/BACKGROUND

The 2024 Annual Report was shared in a variety of ways, including the placement of hard copies at White Rock City Hall, the White Rock Library and the White Rock Museum and Archives.

In accordance with the *Community Charter* there must be an opportunity for public submissions and questions prior to Council considering the Annual Report.
