1. CALL TO ORDER

The Chairperson called the meeting to order at 4:02 p.m.

2. ADOPTION OF AGENDA

Motion Number 2021-PAAC-005: It was MOVED and SECONDED

THAT the Public Art Advisory Committee amend the September 14, 2021 meeting agenda with the inclusion of:

4. DRAFT INTERSECTION ART PLAN REVIEW

The Manager of Cultural Development and guests, Jan Ballard and Alison Meredith from Ballard Fine Arts, provided a presentation of the draft Intersection Art Plan, which included additions and amendments made after receiving feedback from the Committee during the July 13, 2021 meeting.

The Committee discussed this document and provided feedback to the presenters.

Motion Number 2021-PAAC-007: It was MOVED and SECONDED

THAT the Public Art Advisory Committee approves the draft Intersection Art Plan.

Motion Number 2021-PAAC-008: It was MOVED and SECONDED

THAT the Public Art Advisory Committee recommends that Council accepts the approved Intersection Art Plan and directs staff to proceed with this project.

THAT the Public Art Advisory Committee appoints P. Stasieczek as the Committee representative on the Intersection Art Plan artist selection panel.

5. UPDATE ON PROGRESS OF THE CENTRE STREET WALKWAY PROJECT

The Manager of Cultural Development introduced the Committee's discussion with the Director of Engineering and Municipal Operations with a brief PowerPoint presentation pertaining to Placemaking and Public Art, including clarification regarding the similarities and differences between "public art" and "placemaking art."

The Director of Engineering and Municipal Operations provided a brief overview of Engineering's specific priorities and constraints in collaborating with other departments and Committees on placemaking plans. He then provided an update on the progress of the Centre Street Walkway project.

The Committee engaged in a roundtable discussion with the Director of Engineering and Municipal Operations regarding the Centre Street Walkway project as well as other potential collaboration opportunities.

ACTION ITEM: Staff to provide a copy of the original Centre Street Walkway plan from 2014 to Committee members as requested, for information purposes.

<u>ACTION ITEM:</u> The Manager of Cultural Development to report back to the Committee at their October 12, 2021 meeting with an update on the status of the Centre Street Walkway project after it is considered at the October 5, 2021 Regular Council Meeting.

The Director of Engineering and Municipal Operations left the meeting at 5:07 p.m.

6. PUBLIC ART AND PLACEMAKING ART POLICY 708

The Manager of Cultural Development provided an overview of proposed updates to the Public Art and Placemaking Art Policy.

ACTION ITEM: Committee members to further review the updated Public Art and Placemaking Art Policy and provide their feedback and suggestions to the Manager of Cultural Development before the October 12, 2021 meeting so that it can be finalized for referral to Council at the next meeting.

7. NON-VOTING MEMBER APPOINTMENT FOR A PUBLIC ART ADVISORY COMMITTEE MEMBER RESPRESENTATIVE TO SERVE ON THE ADVISORY DESIGN PANEL (WHEN REQUIRED)

At the March 15, 2021 Special Council Meeting, Council endorsed the following resolution:

THAT a member of the Public Art Advisory Committee be appointed to the City's Advisory Design Panel (ADP) as a <u>non-voting</u> member to be invited to ADP meetings when there is a public art component proposed or expected, based on Council Policy 511 Density Bonus / Amenity Contribution.

ADP Terms of Reference provided for information purposes.

The Committee discussed their suggestions for this appointment on the ADP.

Motion Number 2021-PAAC-010: It was MOVED and SECONDED

THAT the Public Art Advisory Committee appoints G. Kennedy (and Y. Everson as the alternate) to serve as a non-voting member on the Advisory Design Panel (ADP), to be invited to ADP meetings when there is a public art component proposed or expected, based on Council Policy 511 Density Bonus / Amenity Contribution, until the end of their term (October 31, 2022).

8. MURAL PLACEMENT AT CONSTRUCTION SITES

Committee member, G. Kennedy, shared key ideas from a recent article he read in the Peace Arch News regarding a mural project happening in Cloverdale.

The Committee then discussed ideas surrounding mandatory mural placement on construction hoarding.

Motion Number 2021-PAAC-011: It was MOVED and SECONDED

THAT the Public Art Advisory Committee recommends that Council direct staff to prepare a report on the requirements for developing a Murals on Construction Hoarding policy.

Motion CARRIED

10.1 SCULPTURE WALK UPDATE

ACTION ITEM: The Manager of Cultural Development to further discuss the Sculpture Walk project with Deanna Pederson and Cindy Poppy, with any updates to be shared with the Committee at the October 12, 2021 meeting.

- Replacement of the "Grizlee" statue at East Beach (replacement statue completed, pending installation);
- Murals on hoarding at construction sites; and,
- 2022 Street art banner call.

ACTION ITEM: The Manager of Cultural Development to meet with the Director of Engineering and Municipal Operations and the Manger of Parks to discuss potential opportunities for further collaboration with the Committee, and to provide an update to the Committee at the October 12, 2021 meeting.

ACTION ITEM: Committee members to bring forward aspirational ideas for their 2021-2022 Work Plan at the October 12, 2021 meeting for further discussion.

ACTION ITEM: Staff to invite the Manager of Parks to attend a future meeting so that he and Committee members can be introduced.
