- C. Lightowlers, White Rock, complimented the City on the initial and continued opening of the Warming Centre and noted she would be in agreement with having it open seven (7) days per week.
- E. Ross, White Rock, inquired if it was Council's intention to keep the voting dashboard on the City website. It was confirmed that it was the intention and that staff are working to update the system to reflect the new Council.
- G. Queen, White Rock, noted concern of a safety issue around a stop sign at Fir Street and Columbia Avenue where there is a two (2) way stop, stated that additional signage on asphalt would be a helpful further safety measure.

Members from the White Rock Pickleball Association (WRPB), John Bogar and Peggy Hof attended to introduce WRPB to the new Council and to outline three (3) requests:

- 1. Urgent need for AED at Centennial Park (noted this had already been addressed by City Administration)
- 2. Completion of work courts on east side courts
- 3. Maintenance of space between the courts.

The following discussion points were noted:

- A Councillor noted consideration of landscaping improvements may be addressed on a volunteer basis. It was noted that staff are monitoring the area (perhaps gear can be hung up in a different location from where improvements are being requested as the area may require a retaining wall which is costly and would not be conducive to utilize volunteers to construct)
- WRPB members are from many areas not just White Rock, the organization values inclusiveness
- consideration of the request will be discussed as part of the upcoming budget process

5.1.b WHITE ROCK EVENTS SOCIETY - CHRISTINE TOBIAS & TRACEY LAMARRE

Members from the White Rock Events Society (WRES), Deanna Pederson and Cindy Poppy attended to discuss the White Rock Sea Festival and Float for 2023. It was noted that the members from the WRES that originally planned to attend were no longer able.
