## 4. CITY OF WHITE ROCK DRAFT 2023 - 2027 FINANCIAL PLAN

Corporate report dated February 13, 2023 from the Director of Financial Services titled "City of White Rock Draft 2023-2027 Financial Plan".

The Director of Financial Services provided a PowerPoint overview of the 2023 - 2027 Operational Financial Plan and the proposed schedule. The budget will be brought forward in two (2) stages. Operational (tonight) and Asset Improvement (Capital) March 13, 2023.

Next Steps:

- February 13, Approval of the Draft 2023 2027 Operational Financial Plan
- March 13, Approval of the Draft 2023 2027 Asset management (Capital) Financial Plan
- March 27, Approval of the Consolidated 2023 2027 Financial Plan and Refer for public comment (14 days using the City's "Let's Talk" online engagement platform)
- March 28 April 10, 2023, Final Consolidated 2023 2027 Financial Plan available for public comment using the City's "Let's Talk" online engagement platform
- April 17, Staff submit "What We Heard" report summarizing all public comments received as "On-Table" item at the Committee meeting
- April 17, Council consideration of initial bylaw readings

• May 1, Council consideration of Budget Bylaw

The following discussion points were noted:

- No asset improvement connected with a grant / reason for decrease in Government Grants for 2027
- City to review parking rates / possible revenue source
- Financial Plan software could still be two (2) years before being ready to be implemented
- Climate Change Grant, can go towards more EV chargers / consideration for electric bike charging stations
- CUPE and IAFF negotiations still outstanding
- The hump vegetation needs attention, \$10,000 will cover maintenance at the top (maple shoots and blackberries, may help with view), further study needed as this has not been done since at least 2017
- Snowbirds plan to attend in White Rock 2023, funding there but it may have to be augmented
- Roads (maintenance and encroachments), this work has not been tracked before (estimates previously)
- A member of Council requested Analysis of Operations Reserves staff will get back on this
- Fire Rescue, medical vs. mental health needs are there stats regarding the types of calls? It was noted this could be reviewed

Motion Number: 2023-F&A-006 It was MOVED and SECONDED

THAT the Finance and Audit Committee direct staff to add the White Rock Museum request in the amount of \$45,000 to the budget for staff adjustments and additional storage.
