4. **CITY OF WHITE ROCK DRAFT 2023 - 2027 CONSOLIDATED FINANCIAL PLAN**

Corporate report dated March 13, 2023 from the Director of Financial Services titled "City of White Rock Draft 2023-2027 Consolidated Financial Plan".

The following discussion points were noted:

- Should parking rates in the up-town area also be reviewed? If this is done more consultation would be required
- Development Cost Charge (DCC) bylaw is anticipated to be reviewed this summer; it will take approximately 9 to 12 months to complete this task.
- Community Amenity Contributions (CAC) are addressed by policy, staff can review this, for the past while the projects coming through have not met the threshold for CAC's to be triggered
- Staff are working on a project with the City's IT staff to show online the resurfacing / paving projects and where they will occur and this will include larger capital projects in future
- Water Utility site on Oxford, would like some information brought forward for consideration of how the site could be utilized

- The City has been notified earlier this month in regard to receiving \$5.7M grant from the province, there has not been any further information regarding the grant and where it will be permitted to be utilized at this point. It has not been noted when the information will come forward but once it does it will be addressed in the budget following discussion with Council
- City vehicle replacements, staff do consider electric options however at this point there is a three (3) year waiting list

1. **A .25 cent hourly increase in waterfront parking for the summer season; and further**


