4.1 CHAIRPERSON CALLS FOR SPEAKERS TO QUESTION AND ANSWER PERIOD

- M. Nelson, White Rock, concern with the condition of sidewalks and gardens on Johnston Road (5 corners to North Bluff Road). There is much effort placed at the Promenade area but there should be a balance where Johnston Road is also addressed. The area looks unkept (cleaning of leaves, pruning of plants and keeping of the gardens are not well tended). The Mayor noted the City's Request for Service option on our website could be utilized for some situations. Council and staff were given photo examples of the concerns to review.
- L. Bailey-Conner, White Rock, concern regarding conditions along Johnston Road, and not being able to walk in certain areas. There are new areas of sidewalk where asphalt has been put down where others have concrete and brick, and the appearance does not look good. Concern that when an area is run down that respect for the

area is not shown.

Staff confirmed that the asphalt is temporary as new utility work is expected to also be conducted, staff will review the areas.

- Owner/Operator, White Rock, Buena Vista Lodge, concern with the facility not being funded further by Fraser Health.
Mayor noted this is a Provincial matter, a letter of support letting Fraser Health know that Council supports the facility remaining open in White Rock may be sent.
- T. Farrow, South Surrey, concern with the potential closure of the Buena Vista Lodge, placement of those from the facility is underway but it does not permit them to stay in their community (not near their family)


