4. QUESTION AND ANSWER PERIOD

Question and Answer Period was held both in person at the meeting, as well as electronically through email.

As of 8:30 a.m., April 12, 2023, there was **one (1)** Question and Answer period submission received:

 Email dated March 31, 2023 from J. Longworth, White Rock, regarding traffic and safety concerns at the Five Corners crosswalk, as well as concerns around sidewalk maintenance.

A response from staff, dated April 11, 2023, has been attached to the submission for information purposes.

4.1 CHAIRPERSON CALLS FOR SPEAKERS TO QUESTION AND ANSWER PERIOD

L. Webber, White Rock, inquired if Council has been presented with the scope of the Centre Street Walkway project?

Concern was noted that a letter has been received from the City stating encroachments need to be removed by May 19th, this is a difficult timeframe.

Staff noted a corporate report is coming back to Council in the next 2-3 months with a plan for project funds of up to \$100,000. Staff confirmed removal of the encroachments is the direction of the current Council.

D. Shaan, White Rock, concern with received notice to remove encroachments along the Centre Street Walkway area. Stated this project has been discussed on and off since 1986 and it is stressful and that \$100,000 is not a lot of funds to carry out the project, there is much work to do. The area is needed for access to their home as the laneway is narrow.

Staff noted the direction has been given to have the encroachments removed, a design concept will be brought forward for the project.

A. Veltri, White Rock, informed that he is having an issue driving to his property. Stated a need for a small road to be put in through the back, concern that fire services cannot get to the property.

Further concerns were noted with the amount of his water bill and neighbours' drainage onto his property.

Mr. Veltri was asked to reach out to engineering staff on this matter regarding his concerns.

A. Bhathal, Surrey (building his home in White Rock), concern noted with the City's tree management program in relation to building new homes. The required tree barrier is so big it blocks access to the property and they cannot start on the building. Further a request for an onsite Arborist during construction is cost prohibitive.

Staff are aware of the matter, and they are working on a response for later this week.

The Director of Corporate Administration noted the following two (2) On-Table submissions for Question and Answer Period:

Two (2) submissions from G. Gumley both presented On-Table in regard to the City's budget:

 Now there is a reduced tax rate from earlier discussion(s) and inquired 1) how this was accomplished and 2) what a non-market fund is? Staff noted Non-market fund refers to the non-market change in the tax rolls. It is the result of new construction/development as well as changes in zoning and exemptions.

It is the same source of funds as the \$125K voted on by the Finance & Audit Committee in February 2023. In February 2023 we had an updated, but not final, revised roll report from BC Assessment, which led to the inclusion of the additional \$125K in the financial plan. The City has since received the final numbers from BC Assessment, which led to the additional \$113K being added into the current (April 17, 2023) financial plan.

It was further noted that at the March 27, 2023 Finance & Audit Committee meeting we started with a property tax increase of 7.3%. At that meeting it was resolved to remove free weekday parking at the waterfront during the winter months, which was a \$75K change and reduced the property tax increase to 7.02%. Since then, we have received the final revised roll which added the \$113K of non-market change revenue mentioned above and brought the property tax increase down to 6.59%.

 Inquired that the Waterfront Asset Improvements has been reduced and inquired if this is the pier restoration budget?

Staff noted the pier restoration project has not been abandoned, it is a carry forward project. A line item must be included in the financial plan in order for the City to make grant applications for the item. The carry forwards for incomplete capital projects have not been included in this version of the financial plan. Once the financial audit has been completed, the financial plan will be updated.
