SUBJECT: General Grants-in-Aid 2023

RECOMMENDATION

THAT Council receive the May 15, 2023, corporate report from the Director of Financial Services, titled "General Grants-in-Aid 2023" for consideration and direct staff on the allocation of the 2023 General Grants-in-Aid funding available.

EXECUTIVE SUMMARY

This report provides information on the 2023 General Grants-In-Aid requests and recommends allocations of the budget available for 2023.

The total 2023 budget for all Grants-in-Aid was set at \$25,000. Internally, \$15K of this funding was allocated to General Grants-in-Aid, and the \$10K balance to Culture Grants-in-Aid. The Grants-in-Aid Culture corporate report from the Director, Recreation and Culture (also on the May 15, 2023, Agenda) recommends allocating \$9,250 and applying the remaining balance of \$750 to General Grants-in-Aid. This increases the total amount available for General Grants-in-Aid to \$15,750 for 2023.

INTRODUCTION/BACKGROUND

The City's criteria and process for administering Grants-in-Aid are provided in City Council Policy No. 302. A copy of the policy is attached (Appendix A). It should be noted that one "general" grant may be awarded per organization per year, with a maximum award of \$2,000.

The City received 24 General Grants-in-Aid applications for 2023. The total amount requested for General Grants-in-Aid for the year was \$46,340, with an available adjusted budget of \$15,750. Applications are available for review in Appendix B.

Previously, the Grants-in-Aid requests had been reviewed by the Grants-in-Aid Sub-Committee. However, for efficiency, this committee was disbanded with the Grants-in-Aid requests being presented directly to Council.

Staff have reviewed the applications in detail, and with limited funds, have made recommendations for allocation of the 2023 funds based on the criteria set out in City Council Policy No. 302, which includes evaluating how the potential grant recipients' program or event is doing "good works" which benefit the people of the City, or bringing favourable publicity to the City and in so doing raising civic pride and awareness. Additionally, staff reviewed how these organizations are supported in other ways by the City and their ability to perform the program or

function without City funds. As stated in the Policy, organizations that receive other funding from the City, for example a permissive tax exemption or operating funding, were given lower priority due to the limited funds available for General Grants-in-Aid in 2023. In summary staff attempted to weigh the impact to the community of the organizations program or event, the organization's internal resources and the resources already provided to that organization by the City.

Methodology for General Grant-in-Aid Review and Suggested Allocation of Funds

- 1. Staff reviewed applications attempting to confirm budgets (ensure the amount requested was reasonable) and obtain financial statements in order to review the organization's financial position. Organizations were organized into three groups based on their revenues from the previous year (to help assess the organization's internal resources available for the applicant's program or event): Low Revenue (less than \$50K gross revenue), Medium Revenue (\$50K up to \$100K gross revenue) and Higher Revenue (over \$150K gross revenue).
- 2. Staff attempted to assess the impact of the program or event to the community (e.g., how many people would be attending or affected by the event or program).
- 3. Staff assessed what other City resources had already been made available to the event or program, including whether the organization received a permissive tax exemption from the City.

In an attempt to make the grants amounts awarded meaningful to those organizations with greater financial need, staff gave funding priority to those within the 'Small' organization category.
