INTRODUCTION/BACKGROUND

The Council and Committee Procedure Bylaw 2393 was adopted in October 2021. This is the second amendment being brought forward for the bylaw.

At the June 26, 2023 regular council meeting a resolution was carried directing staff to bring forward an amendment to the Council and Committee Procedure Bylaw in regard to Question and Answer Period. The proposed bylaw has been amended to follow Council direction given through motion 2023-285.

At this time, staff are also bringing forward a potential amendment regarding the date of agenda publication. Currently the bylaw outlines publication will take place on the Wednesday prior to the council meeting. Staff have found this can be a tight turnaround, particularly on weeks when

there has been a statutory holiday. Staff are proposing consideration of amending this to reflect that the agenda now be published on the Thursday prior to the meeting rather than Wednesday. This timing will be helpful with the agenda preparation as well as give the opportunity for a more efficient agenda review process that could include full draft staff reports rather than agenda topics only by Mayor/Acting Mayor and CAO prior to agenda publication. The opportunity for a full review of the corporate reports will accommodate the various complexities required in providing a well-rounded and informative report.

COMMUNICATION AND COMMUNITY ENGAGEMENT IMPLICATION

Any amendment to the Council's Procedure Bylaw requires notification (through the Peace Arch News) for two (2) consecutive weeks prior to consideration of final reading of the bylaw.

CONCLUSION

In accordance with Council direction in regard to Question and Answer Period and a further proposed amendment for agenda publication timing this corporate report is presented for Council consideration of the initial readings of the *Council and Committee Procedure Bylaw*, 2021, *Amendment No. 2*, 2023 No. 2475 as circulated.
