- K. O'Reilly, White Rock, not in support of the application, noted concerns with the size of the home that is going to be built and the shadowing

impact this may have on neighbouring properties. Noted they would like to see properties with more green space in the area.

- A. Hristova, Coquitlam, designer for the house, noted that delays in building caused the setback needing to be changed for this application.
 Does not believe this house will overshadow others, noted that landscape and trees will remain.
- M. Gosal, Surrey, in support of this application, noted the house is not a "monster" home, and clarified it would be an average sized home.
