9.1.a BYLAW 2477 - WHITE ROCK ZONING BYLAW 2012, NO. 2000, AMENDMENT (CD-46 1454 OXFORD STREET) BYLAW, 2023, NO. 2477

Bylaw 2477 - A bylaw to amend the White Rock Zoning Bylaw to allow for a change in the number of units in Building B (from 43 to 125 units) at 1454 Oxford Street. The OCP and Zoning Amendment for this property were adopted by Council in 2017.

Council waived the option to hold a new public hearing at their June 26, 2023 Regular Council meeting, motion 2023-273, notice of this and September 11th being the date for consideration of 1st, 2nd and 3rd reading has been conducted.

The following is a summary of comments made by Council prior to voting being conducted:

Councillor Cheung: supportive of the application as there is no increase in height, in agreement with White Rock residents being given the opportunity for purchase first, an updated traffic report was provided, additional Community Amenity Contributions (CAC's) are to be provided and enough parking is being provided

Councillor Trevelyan: on the fence regarding the application, busy intersection and there will be an impact on traffic although as noted previously there are many good and fair points for the application

Councillor Klassen: inquired clarification around exiting from the parking lot and staff confirmed the intent would be for a right turn only

Councillor Partridge: supportive of the application stating more housing is needed, many letters of support for this housing and in the price range, more people will help the tax base, traffic will still be lower than other White Rock intersections

Councillor Lawrence: inquired clarification if a construction traffic safety plan would be implemented -
Staff confirmed this would be done and periodic reviews can be made if any concerns are raised.

Mayor Knight: is torn by this application stating it is not affordable housing, additional CAC's will be paid but there is an increase in density so this is to be expected, does not agree that traffic won't be impacted stating traffic on Oxford is already an issue.
