- K. Breaks, White Rock, noted safety concern regarding the crosswalk on Johnston (in front of Blue Frog Studios) as the east side is blocked from view due to the construction. Signage and line painting at minimum needs to be done, would like to see crosswalk lighting put in place (similar to what there is at Prospect Avenue) Staff noted this area is to be addressed under the Johnston Road Phase 3 project; however, repainting the cross-walk markings in the meantime is something that can be considered.
