



Attached please find a draft budget for the 2024 – 2025 White Rock Promenade Sculptures Competition and description of the event.

As of 2023, all infrastructure is in place. The majority of the budget for this year's event went into the construction phase and the People's Choice Award winner.

The inaugural White Rock Promenade Sculptures Competition, by all accounts, is a huge success artistically. Visually, a beautiful addition to the promenade, for sure.

Financially however, that was not the case.

We were delayed a year, which was out of our control, and globally everything became much more expensive, leaving us with a 30% increase in expenses but not in revenue.

We were approved for the \$5000 Grant in Aid in 2022 and then denied this year. The city not wanting to purchase the People's Choice winner was another financial blow. A total of \$20,000 hit on our budget. The city purchasing the People's Choice Award winner is imperative to the future success of this event.

All other cities purchase the winner and add to their growing art displays throughout their communities.

We hope the potential auction in August 2024 will help us recoup some of the \$1000's of dollars we have personally "loaned" the White Rock Promenade Sculptures Competition.

We made a commitment in 2021 to this large-scale artistic event but did not anticipate the lack of support. We thought the majority of people would love art on the beach. They do, they just don't want to pay for it.

We were very fortunate to have sponsors that believed in us and this unique outdoor event, just not enough.

We had a lot of businesses that said they would support us but never followed through.

In 2022, it was suggested to apply to the city as a C event, although we were initially applying as a B. Now, for 2024, it has been suggested to apply as a B event. We would like to know specifically what that means. What is the difference between a B and a C event?

November 20, 2023

Deanna Pedersen and Cindy Poppy, Directors, White Rock Events Society, met with John Woolgar, Director Recreation and Culture and Rebecca Forrest, Manager Cultural Development, November 17, 2023, to discuss the future of the White Rock Promenade Sculptures Competition.

Voting for the People's Choice Award winner and other subsidiary cash awards will end November 30, 2023. We will post the winners on our website and share with the media, sponsors, sculptors, and community.

Our original presentation in 2021 suggested the People's Choice Award winner to be purchased for \$15,000 by the city for permanent display and begin their own sculpture installations around White Rock to build on their desire to be an art community.

We were definitely counting on the \$5000 Grant-in-Aid.

The city delayed the event last year so we began the process again for 2023. Our expenses went up a staggering 30%. Example, construction costs from \$15,000 to \$22,000 plus \$4000 for an engineer. Welding went up to \$14,700. Total \$40,700. Our revenue did not increase by 30%.

At this time we have personally financed the event for \$28,000.

This year has been the most expensive for the event, a year of infrastructure. Concrete slabs have been constructed, pedestals and plates fabricated, costs that will not be incurred in the future.

Less sponsorships and little community support causes us concern for the future of this very successful, anticipated to be, premier artistic event in White Rock. Feedback has been very positive.
