Bylaw 2500 - A bylaw to update the short-term rental regulations within the zoning bylaw to ensure the City aligns with the 90 day provincial parameters established under Bill 35, to provide for ease of enforcement and community expectations. This amendment will broaden the maximum permitted length of stay for short-term rentals from 30 days to 90 days. The proposed amendment also removes references to "accessory vacation rentals" and replaces them with "short term rentals".
